Freshwater Conservation and Water, Sanitation, and Hygiene (FW-WASH)

COMMUNITY OF PRACTICE - ONLINE ENGAGEMENT GUIDE

Overview

The Africa Biodiversity Collaborative Group (ABCG) is supported by the US Agency for International Development (USAID) to advance understanding of critical biodiversity conservation challenges and their solutions in sub-Saharan Africa. ABCG partners are focusing on four key issues that strongly influence the effectiveness of biodiversity conservation efforts: a) land and resource tenure rights, b) land use management, c) understanding the impacts on biodiversity of change processes operating at a global scale, and d) understanding the linkages between global health and biodiversity.

As a result of consultations with freshwater conservation and Water, Sanitation, and Hygiene (FW-WASH) practitioners in an inaugural workshop held in 2014, ABCG set out to explore the creation of a Community of Practice (CoP) with the overall aim of establishing integrated learning between FW-WASH practitioners. This CoP initiative falls under the Global Health and Biodiversity Linkages theme, relating to the integration of FW-WASH. The main goal of the FW-WASH component is to generate knowledge on the impacts of infrastructure developments on watersheds in Sub-Saharan Africa, as well as the impacts of freshwater conservation in meeting WASH goals. By linking freshwater conservation and WASH, ABCG members and CoP participants expect reduced watershed degradation and reduced pollution, and improved health of freshwater ecosystems.

Objectives

The Community of Practice will:

- Provide a collaborative platform and space where global health, development and conservation professionals can share knowledge and expertise, learn, and solve issues together
- Share practical front line on-the-job experiences and the applicability of implementation and monitoring and evaluation (M&E) tools
- Provide a platform for practitioners to share resources
- Enable FW-WASH practitioners to connect and organize around common issues

Activities

The CoP will be managed by ABCG's staff members based in Nairobi, Kenya and Washington, DC, in line with ABCG's engagement strategy which seeks to strengthen outreach and engagement with partners in sub-Saharan Africa. The CoP will be strengthened by the presence of five of the seven ABCG members which have offices in Nairobi.

The following activities will be carried out:

- Online discussion
- Online webinars
- Face to face thematic meetings
- Brown bags to showcase case studies
