### **Coordinator, Law enforcement & Governance**

**Location:** Maputo, Mozambique

The Wildlife Conservation Society (WCS) Mozambique is seeking a dynamic, experienced individual with a background in governance and law enforcement of transnational wildlife crime to fill its Coordinator position. She/He will coordinate the strategic development and implementation of counter-wildlife trafficking work for WCS Mozambique with a focus on links to anti-poaching activities in WCS Mozambique's primary landscape - Niassa National Reserve.
