1.0 Executive Summary

The Africa Biodiversity Collaborative Group (ABCG) has been implementing a program called Biodiversity Analysis and Technical Support (BATS) with technical support from the United States Agency for International Development (USAID) since 2008. According to an annual report by ABCG (2012), the BATS program is a multi-partner USAID Bureau for Africa effort that includes International Resources Group (IRG) under the Environmental Policy and Institutional Strengthening Indefinite Quantity Contract (EPIQ II), the USDA Forest Service International Programs under an interagency agreement, Environmental Law Institute (ELI), the Capitalizing Knowledge, Connecting Communities (CK2C) project of new partner Development Alternatives Incorporated (DAI) and the Africa Biodiversity Collaborative Group (ABCG) under a cooperative agreement.

ABCG is a coalition of the major US-based international conservation non-governmental organizations (NGOs) with field-based activities in Africa including African Wildlife Foundation (AWF), Conservation International (CI), the Jane Goodall Institute (JGI), The Nature Conservancy (TNC), Wildlife Conservation Society (WCS), World Resources Institute (WRI) and World Wildlife Fund (WWF). ABCG has extensive experience conducting analysis and sharing lessons learned on high priority conservation issues affecting Africa. ABCG's mission is to tackle complex and changing conservation challenges by catalyzing and strengthening collaboration, and bringing the best resources from across a continuum of conservation organizations to effectively and efficiently work towards a vision of an African continent where natural resources and biodiversity are securely conserved in balance with sustained human livelihoods (ABCG BATS Annual 2012).

The ABCG's BATS Cooperative program has a number of tasks and deliverables. One of the tasks is to "equip governments, NGOs and partners to better address the intersections of global health challenges and biodiversity (Task G)". Under this task, two deliverables specific to HIV/AIDS and Environment were isolated. These are:-

- 1. Training materials developed in consultation with HIV/AIDS and environment experts that are appropriate for conservation staff and partners
- 2. A training workshop are held for conservation staff and partners in South Sudan

To achieve the two activities, ABCG was tasked to identify and hire a consultant to lead the development of the materials and facilitate a workshop with one of the partners in South Sudan. Daulos Mauambeta was identified to lead this process. The Inception Report provides details to the approach and methodology to be used in this consultancy and work plan to be followed in order to achieve the stated deliverables.

This report is divided into seven sections. The first is this executive summary; followed by a section on background information to the consultant; the third section is methodology and approach to this consultancy; section four is proposed work plan; section five us proposed travel plans and costs; section six is the proposed workshop training agenda with section seven being the conclusion.

2.0 Background Information to Daulos Mauambeta

Daulos Mauambeta holds a *Master of Science Degree in Forestry and its relation to land use* obtained from the University of Oxford (1993-1994) in addition to several professional and undergraduate qualifications.

Daulos Mauambeta has over twenty years of professional experience in sustainable land use practices including conservation agriculture, agroforestry, permaculture, wildlife and forestry management; soil and water conservation, eco-tourism; environmental education; biodiversity conservation; community based natural resources management (CBNRM), agro-based and natural resource based enterprises; and general food security and livelihoods issues. He is good at project formulation and management; facilitation, teaching and training; socio-economic and ecological research; organizational development; sustainable financing and fundraising; advocacy, lobbying and communication; strategic and tactic planning; budgeting and expenditure forecasting; financial and human resources management; reporting, monitoring and evaluation; coordination and networking; and general administration.

He was for 12 years from 1997 to 2011 the Executive Director of the Wildlife and Environmental Society of Malawi, where he was responsible for implementing a broad range of natural resources management projects.

Daulos Mauambeta has been doing consultancy work in various areas including conducting baseline surveys for programs and projects; conducting mid-term and end of project/program evaluations; project proposal development and reviews; book / report reviews, organizational development and capacity building to mention but a few. Apart from consulting, Daulos Mauambeta is also a Senior Lecturer in the Department of Geography and Environmental Studies at Catholic University of Malawi where he lectures natural resources management, land use planning, geographical information system, remote sensing and hydrology.

He is an advocate of rural development using Participatory Integrated Community Development (PICD) approaches such as Participatory Rural Appraisal (PRA), Appreciative Inquiry Assessment (AIA); STAR Study Circles and similar approaches. He is also a monitoring and evaluation champion of programs using various tools such as Management Oriented Monitoring Systems (MOMS) and Performance Monitoring and Evaluation. Mr. Mauambeta has experience and skills in emerging issues such as development of Sector Wide Approaches (SWAps); Climate Change including REDD+ Issues; quality basic and tertiary education; linkages of HIV & AIDS and conservation; and Gender Issues in development.

Daulos Mauambeta has been a world champion on issues of HIV/AIDS and Conservation since 2002. In September 2002 to June 2003, Daulos Mauambeta went on a Hubert Humphrey Fellowship Program at the University of Washington in Seattle, United States of America. During that period, he had a chance to work with the World Wide Fund for Nature (WWF)- USA and the Africa Biodiversity Collaborative Group (ABCG) based in Washington D.C. on establishing a program on mainstreaming HIV/AIDS in Conservation Organizations. Daulos Mauambeta shared his experiences and wrote case studies about his cutting edge work to mainstream HIV/AIDS into conservation organizations including his organization, the Wildlife and Environment Society of Malawi. Since then, he has been a tireless

champion for this issue in Malawi, Africa and globally. He has advocated for HIV & AIDS mainstreaming in conservation organizations. He has implemented various programs termed 'awareness to action' on HIV & AIDS in and around protected areas. He has trained staff and local communities on issues of HIV & AID and conservation.

Daulos Mauambeta has conducted research, written and presented reports and papers on HIV & AIDS conservation linkages at home, Africa and globally. For example, he has made presentations at Mweka Wildlife College in Tanzania (2004); IUCN's Southern Africa Sustainable Specialist User Group (SASUSG) Annual Meeting in South Africa in 2007; IUCN's Southern Africa Sustainable Specialist User Group (SASUSG) Climate Change Health and Sustainable Use Group Meeting in Cape Town in South Africa (2008); IUCN's World Conservation Congress in Bangkok in Thailand (2008); Environmental Education Association of Southern Africa (EEASA) Conference at the University of Botswana (July 2009); Rhodes University in South Africa (August 2009); Joint International Meeting of the Association for Tropical Biology and Conservation and the Society for Conservation Biology (Africa Section) in 2011; His work has widely been published including in the Wildlife Conservation Society's 2008-2009 State of Wild, A global portrait of wildlife, wildlands, and oceans with a special section on Emerging Diseases and Conservation: One World-One Earth and Population & Environment, Published by Sierra Club, United States of America.

3.0 Methodology and Approach

The approach to this consultancy includes the following key elements:

- ✓ Scoping discussions: The Consultant is holding e-mail, telephone and skype discussions with ABCG Management Team to finally agree on this Inception Report and deliverables.
- ✓ Review background documentation: Through literature reviews, key informant interviews and internet searches, relevant key documents are being identified, obtained and analysed.
- ✓ Conduct a baseline survey for key informants: The consultant is developing a
 checklist of questions to be administered to partner staff in South Sudan to assess their
 knowledge, attitudes and practice about HIV/AIDs and Conservation as part of a
 baseline.
- ✓ **Development of a HIV/AIDS and Environment Manual:** Based on the literature review and the current draft manual being developed by ABCG, an easy to read and understood manual shall be developed.
- ✓ Conduct training workshop: The consultant shall facilitate and conduct a training workshop for ABCG Partners and Members on HIV/AIDS and Conservation work place policies in South Sudan.
- ✓ Reporting: The consultant shall produce a comprehensive well written report with clearly-explained conclusions and recommendations on the two deliverables- the training manual and the training workshop on HIV /AIDS and Environmental Conservation.
